### OFFICIAL RULES TSRA Directors for 2019-2021 Terms Official Ballot

Ballots must be personally marked and signed by the TSRA member. **Multiple members of the same household may vote on the same ballot, however, each member must sign the form and designate which member voted for which candidate (for verification purposes only).**

Only individual members are eligible to vote. Associated clubs, organizations, and business members are not eligible to vote.

Only the official TSRA ballot will be accepted. Ballots received that are not in accordance with the official Bylaws of the association will be considered invalid. A ballot judged invalid shall have the reason noted thereon and be initialed by the person who examined it.

All ballots, whether judged valid or invalid, and all return envelopes, shall be preserved by the Association for 120 days. Thereafter, said ballots and envelopes shall be destroyed.

The results of the election by mail ballot will be announced at the Annual General Meeting and shall be published in the TSRA Sportsman within 90 days of the announcement.
