2019 Schedule

Dates: Third Sunday of the month. Jan. 20, Feb. 17, Mar. 17, Apr. 21, May 19, Jun. 16, Jul., 21, Aug. 18, Sep. 15, Oct. 20, Nov. 17, Dec. 15, 2019.

Eligibility: This is a NRA Approved Match, open to any competitor. Membership in the NRA is not required. Juniors must have a handgun authorization form signed by their parent or guardian. The form is included on the last page of this program.

Entries: Entries will be accepted at Range A beginning 8:00 am until 8:45 am. Match is limited to 40 competitors.

Entry Fees: Full 2700 (Three guns - .22, CF, .45) - \$20. Two guns - \$15. One gun - \$10.

Firing Time: Time permitting, a 10 minute preparation and sighting period (unlimited shots, any gun) will begin at 9:00 am. The .22 stage of the match will begin after this sighting period. There will be a 10 minute break between the .22 and Center Fire portions of the match and a 40 minute lunch break between the Center Fire and .45 portions of the match.

Rules: Current NRA Precision Pistol Rules and classifications will govern. Unclassified competitors will compete in the Master class. Classes with less than four competitors will be combined with the higher classification. Empty chamber indicators and eye & ear protection are required.

Scoring: Competitors will score and repair targets.

Targets: Official NRA targets (B-6 50 Yard Slow Fire, B-8 25 Yard Timed & Rapid Fire) will be used.

Course of Fire: Standard NRA 900 Match (20 shots Slow Fire, 30 shot National Match Course, 20 shots Timed Fire, 20 shots Rapid Fire) for each of three guns - .22 LR, Center Fire, .45.

Facility: Firing points are covered with 50 yard fixed targets and 25 yard turning targets. There are portable restrooms on property. Food and/or drinks are not available on property. Limited RV parking may be available with prior arrangement.

Range Location: The match will be held at the Austin Rifle Club (ARC), 16312 Littig Road, Manor, Texas 78653. GPS coordinates: 30° 19' 28.34" N 97° 28' 36.24" W

Directions: From the East via US Hwy 290, approximately 7 miles west of Elgin turn left on Old Kimbro Road. After 1 ¼ mile turn left (across the railroad track) onto Littig Road. The range is approximately 2 ¼ miles. Take the second entrance to the range (after the white ARC building).

From US Toll Road 45/130, take the US 290 exit towards Manor. After 3 miles turn right on 212/973. In ½ mile turn left onto Old US 290. After 2 miles turn right (across the railroad track) on to Littig Road. The range is approximately 2 ¼ miles. Take the second entrance to the range (after the white ARC building).

Access to the ARC facility is via an automatic gate. Contact match director for gate access. Non-ARC members will require a blue guest wristband that will be provided at check-in and must be worn at all times on the property. Liability waiver forms must also be signed at check-in.

The competition will take place on Range A. As you enter the facility, drive straight across the bridge and follow the road around to the left as far as it goes.
