Directions to Range

From Marble Falls head east on Hwy 1431 for 6.3 Miles to Hidden Falls Adventure Park. **Park entrance fee is free for scheduled rifle matches only. All other activities are subject to additional fees.** Range is located approximately 1.5 miles from park headquarters. Park is located at 7030 East FM. 1431, Marble Falls, Texas 78654. Host will be at the gate at 7:30 am for early entrance information.

Host will be at the entrance to provide directions, sign releases, and provide mirror placard.

Rules: Current NRA Small Bore Rifle Rules will govern. Also check NRAHQ.org .

Eligibility: All competitors must be individual members of TSRA. All competitors will fill out a TSRA membership application. NRA classification cards may be exhibited at time of squadding.

Entries: Will close at 0830 on the day of match. Limited to 50 (Get your entries in early!)

Time of Firing: Competitors to firing line 0830 each day. Firing starts at 9:00 am. In case of a backlog at the front gate we will wait until all enter.

Squadding: All competitors will be assigned target number.

Challenges: A challenge fee of \$1.00 will be charged for each challenge made. NRA rule 16.
Classification: The NRA classification system will be used in all matches. Unclassified adults will shoot in master class. 3 competitor's minimum per classification. Classification with less than 3 competitors will be classed up.

Awards: Awards for Winners in Match 11 Only! You must shoot both days to be eligible for awards. State Champion award will go only to a Texas Resident. Everyone is eligible for all other awards.

Photography? Photos of competitors will be taken at this match for the purpose of publication in the TSRA magazine. Your presence at this match signifies your acceptance of your photo for this magazine. If you do not want you, or your child's photograph used for the TSRA publication you must notify the match director at the beginning of the match.
